

§ 92.003 COMBUSTIBLE REFUSE.

It shall be unlawful to permit or store any combustible refuse in such a way as to create a fire hazard, or to store or throw away any refuse of any kind in any alley, street, or other public place in the city.

§ 92.004 BURNING TRASH; BONFIRES.

(A) No person shall burn or cause to be burned any sweepings, trash, paper, lumber, straw, hay, or any combustible material. This section shall not prevent the making of bonfires on occasions provided that permission therefor in writing shall have first been obtained from the Fire Chief. ('60 Code, Ch. VII, Art. (B) It shall be unlawful to build or light any bonfire so close to any building or other structure as to endanger such building or structure, or on any street or sidewalk pavement. ('60 Code, Ch. XVI, Art. V, § 10) (Ord. 60-1, passed 12-19-60)

§ 92.005 LEAF BURNING.

It shall be unlawful for any person, firm, or corporation to burn any trash, garbage, or waste matter within the city except for outdoor burning of leaves, plants, shrubs, and small limbs on private property, on Wednesdays and Saturdays only during the time period of October 1 through April 30 of each year, only during daylight hours of each day, only during a calm weather period with winds of less than ten miles per hour, and the burning shall be supervised and a water hose shall be available to extinguish the fire, if necessary. In addition, outdoor leaf burning must be done at a minimum of 15 feet from any structure and shall include only leaves falling from trees, plants, and shrubs. No leaf burning shall be allowed on any public street or alley and shall occur on private property only, except leaf burning may be conducted on public property when initiated and supervised by employees of the public agency owning the property. Leaf burning permitted under this section may be prohibited at any time when, in the opinion of the appropriate and proper official of the city or the Illinois Environmental Protection Agency, that these very conditions are such that open leaf burning would prove harmful to the health or welfare of the citizens of the city.

§ 92.006 DUMPING MATERIAL WHICH MAY CAUSE FIRE.

No person shall dump any material on any private property which may be likely to take fire, be set afire, or cause fire.
