Interim City Manager Chief Stahlhut explained while our Public Works department was working on a water line on Grand Rapids Lane it was recognized that one of the carpenters from Fulford Homes went into cardiac arrest and stopped breathing. Having the employees present that had the knowledge to perform early life saving efforts, involvement of our dispatchers, arrival of our police and fire departments in addition to Alton Memorial Ambulance resulted in the patient surviving and returning to work.

CITIZEN/OFFICIAL COMMENTS:

Bill Dettmers received documents from a FOIA request about the costs of certain projects. In his review of the documents, he stated that the City plans to keep a 20% reserve in contingencies in the 1% sales tax. The Rec Center and East End detention pond projects are going to run about \$900,000 a year leaving \$450,000 left to fund other projects. The other projects anticipated to use the funding for were the 6th Street Basin and Sewer Separation Plant that would be around 8-9 million dollars combined. He stated that those numbers are several years old and have likely increased. There has been a 60% increase on the cost of the Rec Center. If the projects come in at 50% or more increase in cost, it would be 12 million dollars with a \$600,000 a year payment which is over the \$1.4 million threshold. The sewer treatment plan cost of \$15 million is also several years old. The costs are running a deficit in the sewer fund. \$300,000 was transferred from the general fund to the sewer fund depleting the funds planned for the Treatment Plant.

Karen Carr lives on the 600 block of 1st. She loves being by the High School, however, during events when the parking lot becomes full people park in the 600 block to go to school events. This leaves no place for her and the residents of this block to park. She asked if the City could put in a parking for residents only sign.
