# PUBLIC HEARING MS4 PERMIT

The MS4 Permit is good for five years and an annual report is submitted to the EPA. This public hearing is part of the report.

# **CITIZEN/OFFICIAL COMMENTS:**

Bill Dettmers stated he did not realize that a comment he made a couple weeks ago would be so misunderstood so he hopes he can correct any misunderstandings. He does not criticize the City for applying for the grant for the ballfield. He does, however, hold the City accountable for making bad decisions like not performing a feasibility study for the new Recreation Center. In addition to focusing on economic growth and infrastructure projects, he wishes the City would focus on the substandard schools and attract younger families to the community. He wants to guarantee that the Golf Course and the Water and Sewer Operations will not be sold in the future.

City Manager Steve Palen introduced Cory Jobe, President and CEO of Great Rivers and Routes Tourism Bureau. Mr. Jobe addressed the Council regarding the proposal to better promote, market, and develop the City of Wood River.

Councilman Plank stated the City will be showing a loss in the budget for the Recreation Center Funds even with the \$56,997 transferred from the General Fund.
