RESOLUTION NO.

A RESOLUTION IN SUPPORT OF AN ILLINOIS TRANSPORTATION ENHANCEMENT PROGRAM (ITEP) GRANT APPLICATION FOR BICYCLE AND PEDESTRIAN IMPROVEMENTS IN AND AROUND DOWNTOWN WOOD RIVER.

WHEREAS, the City of Wood River, located in the County of Madison, State of Illinois, desires to participate in the construction of bicycle and pedestrian facilities with crosswalk improvements on Ferguson Avenue, between Haller Street and 4th Street (the "Project"), to complete the network in this area and enhance non-motorized transportation in Downtown Wood River; and

WHEREAS, the City of Wood River has prepared and adopted the Wood River Comprehensive Plan and Wood River Bicycle and Pedestrian Plan, and has determined that the Project is consistent with the strategic priorities identified in those plans; and

WHEREAS, an Illinois Transportation Enhancement Program (ITEP) Grant will fund 80% of eligible preliminary engineering, design, construction, and construction engineering and 50% of right-of-way and street lighting of the proposed improvements with the remaining costs and ineligibles to be paid for with local funds.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Wood River as follows:

Section 1: The foregoing recitals are hereby incorporated into, and made part of, this Resolution.

Section 2: The City of Wood River does hereby commit to paying up to 20% required local match to complete the design, construction, and construction engineering and up to 50% required local match for right-of-way acquisition and street lighting, and all ineligible costs associated with the Project.

Section 3: This Resolution shall be in full force and effect from and after its passage and approval as provided by law.
